AND THE AFT PART-TIME FACULTY UNITED, LOCAL 6286, AFL-CIO**


ALL COLLEGE DAY STIPEND

This Memorandum of Understanding between the Victor Valley Community College District and the AFT Part-Time Faculty United, Local 6286, AFL-CIO, is expressly made pursuant to the Educational Employment Relations Act and the parties' collective bargaining agreement. All other provisions in the Collective Bargaining Agreement shall be deemed to remain unchanged unless otherwise expressly stated.

For the Fall 2024, the District will provide a \$165.00 stipend to part-time faculty who attend and sign-in to the on-campus All-College Day professional development opportunities offered by the District on August 23, 2024 (morning session, 9:00 am to 12:00 pm).

This MOU is a temporary agreement that does not create any precedent nor establish any past practice for future bargaining purposes.
